The Thymine base in the DNA decompose after 6 hours of death (Doss, 1999). With regard to fingerprints, Dr. Halim writes that fingerprints also never match even between copies. Genetic engineering and cloning leads to the genetic selection system, which leads to a racism and supremacy based on genetic purity that is difficult to treat as it appeared in the American movie Gattaca (1997).
